A first presentation to the Cypriot research community about CoARA has taken place in May  $11^{\rm th}$  2023 and there are already plans in place for a follow-up workshop in October 2023 with the main academic and research actors to explain in more depth and discuss the CoARA provisions and the steps that need to take place by these institutions to kickstart their self-reflection process and find ways to contribute with their involvement in the ambitious transformation foreseen by the Coalition. It is expected that through the foreseen actions of the National Chapter, a significant number of institutions will join CoARA by the end of the 2-year period.

Added value of the National Chapter over and above what is currently being done within the country (300 words max)\*

Not much has been taking place in the research assessment front in Cyprus. Therefore, the effort of UCY and EOC to kickstart this process through asserting the National Chapter of CoARA will be essentially the first step to this direction. The added value will be substantial since, especially the private universities and research institutions, lack behind in terms of addressing the ERA priorities and actions and their involvement in CoARA will be a natural way to synchronise their policies with the ERA priorities.

UCY and EOC are in full sync regarding CoARA and a number of funded projects will serve the mission of achieving the foreseen transformations. There have been already some preparatory actions toward exploring the transformations needed for the reform in research assessment to be achieved and these concern Open Science (open access, reproducibility, integrity and citizen engagement), evaluation of researchers and

grant applications and incorporation of these factors in shaping research careers). Within 2023 and 2024 a number of actions are foreseen which will gradually lead to more Cypriot organisations becoming members of CoARA but also a number of incremental transformations to the desired direction being achieved. These actions are listed below and are followed by an indicative list of deliverables.

- 3 Info days for CoARA will be organised (1 in 2023 and 2 in 2024) of which 1 will be a stakeholder event open to all interested parties with potential participation of the CoARA Board and/or Secretariat

- A working group of all Research Managers and Administrators in Cyprus is foreseen to be created which will also act as a working group of the CoARA National Chapter.

- A scientific working group was assigned to work on pilot actions relevant to CoARA. More specifically, the SInnoPSis research group which specialises on Science and Innovation Policy and Studies and meta-research will lead the effort of exploring the degree to which CoARA provisions are met and carry out the scientific validation of policies, methodologies and practices for UCY initially and then for each Cypriot organisation that becomes a member of CoARA.
