Short description of the mission and objectives of the group, and of how it fits with the overall CoARA vision (200 words max)*

The **mission** of the Spanish Chapter at CoARA is to support the reform of research assessment in Spain, recognising the diverse outputs, practices and activities that maximise the quality and impact of research (CoARA vision).

The **objectives** of the Spanish Chapter are in close connection with the commitments of the Agreement, with particular attention to:

- Commitment 6 by creating a joint initiative to promote and support the revision and development of the research assessment criteria, tools, and processes in Spain, in line with the Agreement principles and criteria described in the four core commitments.
- Commitment 7 by engaging with research performing and research funding organisations as well as evaluation agencies and researchers' associations in Spain, whether they have signed the Agreement or not.
- Commitment 8 by enabling mutual learning within the Chapter and in collaboration with the CoARA working groups.

Expected impact (notably expected adoption and implementation scenarios) (300 words max)*

The European reform initiative opens an opportunity to reflect on the research evaluation system in Spain and will allow proposals for improvement to be put forward in line with the rest of the international research community so that research and innovation in Spain can continue to grow in excellence and, academic and societal impact.

The Spanish Chapter will allow the following:

1. Plan the objectives to be achieved with the reform in the results and impact of research in Spain by 2030.
2. Co-design possible evaluation systems with the contribution of the institutions and organizations that form the research and innovation ecosystem in Spain.
3. Test the results of this reform in the form of pilot projects in the different recipient institutions, considering the impact on the evaluating bodies, and on the elements to be evaluated: individuals, research units, institutions, and projects.
4. Implement the reform both simultaneously at a national level and gradually to minimize a negative impact on the research careers that are currently being developed.

Added value of the National Chapter over and above what is currently being done within the country (300 words max)*

Early this year, the Spanish Conference of Rectors and the Ministry for Universities launched in Barcelona the [Foro para la Reforma de la Evaluación de la Investigación en España](#). More than 60 organisations started then an open dialogue on reforming research assessment in Spain. One of the main conclusions of that meeting was the need to continue this conversation at the Spanish level, bringing as many stakeholders as possible to promote a systemic reform.

This event marked the initial phase of the reform process, which now requires consistent efforts to foster a productive debate among academics, institutions, agencies, and administrations in order to forge progress. Leveraging the outcomes of this inaugural gathering, the CoARA Spanish Chapter will establish the necessary framework and platforms to sustain collaborative work at the national level, while closely cooperating with other European countries and CoARA.

The CoARA Spanish Chapter would be a cornerstone in the materialisation of the cultural change that the reform of the research assessment of the Agreement proposes.

Work plan and outputs / deliverables, that can be accomplished within the timeline proposed (600 words max)*

Internal organisation: structure, work packages and deliverables

In line with CoARA Commitment 8 to exchange practices and experiences that enable mutual learning within and beyond the Coalition, the NC Spain will bring together a diversity of entities that are both member and non-members of the Coalition and that are of different nature. The work will be organised internally in such a way that favours the development of a rich repository of best practices and guidelines with the aim of jointly developing a set of criteria, tools and procedures that can be shared between all the Spanish entities involved.

We propose to organise the NC Spain around **three lines of work** that address the main areas of concern for research assessment nationally as identified in the Forum launched by Crue Spanish Universities and the Spanish Ministry of Universities early this year. Drawing from the conclusions of this national event, we identify the following to initiate the discussion in the next two years:

1. Assessment criteria and methodologies
2. Awareness and training
3. Addressing multi- and interdisciplinarity

Each line of work will be addressed by a **working group (WG)**. These three WGs will structure their work into **4 phases**, resulting in **4 specific deliverables**:

3	Implementation of Small Pilot Projects to test the identified best practices at a national level. Assessment and Evaluation Commissions and Committees within the proposing and participating entities can be promoted, including those in universities and within ANECA. These are suggested to act as testbeds for the pilot projects.	D3 Report to present and analyse the results of the Small Pilot Projects and the implementation of different assessment methodologies.

4	Proposals and recommendations for advancing in the reform of research assessment in Spain. Final evaluation of the first two-year progress and identification of next steps.	D4 Proposal and recommendations for next phase of project implementation. Key takeaways.

For each phase, the work will be coordinated into one deliverable, making a total of **four unique deliverables (D1-4)**. These joint deliverables should integrate the work of the three working groups to favour collaboration between them. Working together in a coordinated manner will enhance information-sharing between lines of work and favour the identification of possible synergies between them. Moreover, each work package is expected to analyse differentiated assessment challenges by **targets** (individuals, projects, units, and institutions) and **domains** (Physical Sciences and Engineering, Life Sciences, and Social Sciences and Humanities).

Management and coordination

Promoting joint activities within the NC Spain

To coordinate the work of the three WGs, as well as the internal coordination meetings within them, the NC Spain will organise joint seminars and workshops that will aim to promote coordination and communication between WGs, as well as to facilitate the development of the four joint deliverables.

Liaising with other NC and WGs

It will be fundamental to ensure a solid liaison between the NC Spain and other groupings within CoARA (NCs and WGs). This will allow to incorporate discussions and best practices of relevance to the work NC Spain, and to identify and organise joint initiatives with other NCs around similar systems across Europe.

Communication and dissemination

Aligned with CoARA Commitment 7, the NC Spain will put forward activities to raise awareness of research assessment reform and provide transparent communication, guidance, and training on assessment criteria and processes as well as their use. To this end, the NC Spain will organise and participate in events, both at a European and at a national level, including debates, webinars and forums that promote the discussion among Spanish entities. Moreover, the NC Spain will publish and disseminate the findings that result from the WGs in the four deliverables foreseen.
