






CoARA Membership by Country



How WGs Address the Core Commitments of the ARRA



12

- I. Recognise the diversity of contributions to, and careers in, research, in accordance with the needs and the nature of the research.
- 2. Base research assessment primarily on qualitative evaluation for which peer-review is central, supported by responsible use of quantitative indicators.
- 3. Abandon the inappropriate uses in research assessment of journaland publication-based metrics, in particular the inappropriate uses of journal impact factor (JIF) and h-index.
- 4. Avoid the use of rankings of research organisations

in research assessment.


